Health Information

Educational Information

The sources of drinking water, both tap water and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which shall provide the same protection for public health.

Additional Health Information

Lead can cause serious health effects in people of all ages, especially pregnant people, infants (both formula-fed and breastfed), and young children. Lead in drinking water is primarily from materials and parts used in service lines and in home plumbing. Montello Waterworks is responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in the plumbing in your home. Because lead levels may vary over time, lead exposure is possible even when your tap sampling results do not detect lead at one point in time. You can help protect yourself and your family by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Using a filter, certified by an American National Standards Institute accredited certifier to reduce lead, is effective in reducing lead exposures. Follow the instructions provided with the filter to ensure the filter is used properly. Use only cold water for drinking, cooking, and making baby formula. Boiling water does not remove lead from water. Before using tap water for drinking, cooking, or making baby formula, flush your pipes for several minutes. You can do this by running your tap, taking a shower, doing laundry or a load of dishes. If you have a lead service line or galvanized requiring replacement service line, you may need to flush your pipes for a longer period. Actions Taken

Violation started in 2023 and the Waterworks Department has been working on getting all properties compliant by talking in person, on phone, email, and letters. The Waterworks department also went forward and hired a company to get the required inspections done.

Exposure to lead in drinking water can cause serious health effects in all age groups. Infants and children can have decreases in IQ and attention span. Lead exposure can lead to new learning and behavior problems or exacerbate existing learning and behavior problems. The children of women who are exposed to lead before or during pregnancy can have increased risk of these adverse health effects. Adults can have increased risks of heart disease, high blood pressure, kidney or nervous system problems.

Copper is an essential nutrient, but some people who drink water containing copper in excess of the action level over a relatively short amount of time could experience gastrointestinal distress. Some people who drink water containing copper in excess of the action level over many years could suffer liver or kidney damage. People with Wilsons Disease should consult their personal doctor.

We failed to develop an inventory that meets all federal requirements and/or to make the inventory publicly accessible. We failed to submit this initial inventory of service lines by October 16, 2024.

Uncorrected Significant Deficiencies

SD1 The City has not addressed a deficiency from the 2020 sanitary survey. As a result, the deficiency has been elevated to significant and failure to complete the required corrective actions will result in a Treatment Technique Violation (TTV) in accordance with section NR 809.328(1), Wisconsin Administrative Code. The requirement from the 2020 sanitary survey report is included in italics. Montello is not requiring owners of private wells to provide documentation of a well inspection report by a licensed well driller or licensed pump installer in accordance with s. NR 810.16, Wis. Adm. Code. Currently the waterworks operator is verifying that the well meets the requirements of NR 812, Wis. Adm. Code; however, certified waterworks operators are not authorized to complete Form 3300-305. All the existing private wells in the City have permits that expire in 2020; renewal of these permits shall not be allowed unless Form 3300-305 is submitted. This issue dates back to 2018 when the department notified City staff that waterworks operators are not qualified to confirm that the well and pump meet the current NR 812 standards.	11/22/2023	12/31/2024

Actions Taken

Property owners have been notified to become compliant by the end of June 2025 or the water service will be discontinued until they reach proper compliancy per DNR code for private wells.
